RULES AND REGULATIONS

Display privileges are open to all active domestic or international member of MDA who offer musical products or services for sale through wholesalers, distributors or manufacturers.

Manufacturers' representatives who are members of MDA are entitled to one display space regardless of how many lines they represent, unless the companies they represent are also dues paying members. In this event, the other company members may also have space.

Admission to Show & Tell Day is restricted to MDA members. Please encourage your customers who are MDA members to attend, but absolutely no non-member companies are allowed in the hall.

Please do not invite your staff to the hall. Only two representatives per table will be allowed in unless they are authorized buyers. Please do not invite guests.

Exhibit hours are from 9:30 AM until 5:30 PM, with a one-hour lunch break. Lunch will be provided, and meetings and conversation continue during lunch.

The exhibit hall will open at 8 AM on Tuesday morning to allow exhibitors time to set up. MDA reserves the right to give your table to any stand-by exhibitors if you do not arrive by 9:30 AM. Refreshments and lunch will be provided.

Tables are approximately 6 feet by 2-1/2 feet. Each table includes a cloth cover; four chairs; and one MDA-supplied sign with the legal name of the company or representative, city, state, and table identification number. Each table must be attended during the entire day. All tables will be equally spaced in one large ballroom. Table locations will be pre-assigned by MDA.

The identifying sign provided by MDA will sit on the table during exhibit hours. No additional signs, banners, or other means of company or product identification will be permitted. The signs are the property of MDA and will be collected at the end of the day for future use.

No additional or supplemental lighting, lamps, spotlights or added illumination will be provided or allowed. There will be no electricity offered to exhibitors. **Wireless Internet access will be provided.**

Only merchandise that may be placed on the table will be allowed for exhibit or display. No merchandise is to be placed in front or next to any table. The only exception will be a floor type display or rack display that may be placed behind your chairs, provided it is not as wide as the table itself, and does not interfere with or block the view of a neighboring exhibitor. If you must have floor material, please request a back or side table.

Cartons and packing material may be kept neatly under or behind your tables. Participants must clean their area at the close of the session and not leave any debris, refuse, or packing materials. Show & Tell will end immediately at 5:30 PM.

Demonstrations are acceptable, however, no playing of any instruments or equipment will be allowed. Please keep voice level down so as not to disturb others.

MDA is not responsible for loss or damage of any kind.

There is no smoking allowed in the hall.
